

Do you know "Guarantor" that is a peculiar system to Japan?

When trying to rent a house or an apartment in Japan. there is a tenant (renter), a landlord (rentee), a broker and a 'guarantor'. A guarantor follows the same 'rules' as the tenant and must pay the remaining rent or fees if the tenant disappears or stops paying what they should. When a Japanese national needs a guarantor for something, they usually ask someone very close to them. someone they can trust, and who trusts them. However, if a foreign national needs a guarantor, it usually needs to be a Japanese national. Of course it depends on the company but in many cases companies ONLY cater to Japanese nationals and a foreigner isn't even considered for a house or an apartment, even though they might be working or have enough money to pay. More time and money is spent on looking for an apartment that doesn't need a guarantor, and the apartments available are very few and sometimes not very nice places to live, being very old or in inconvenient places.

Apply for Specialized Foreign National Guarantor Service.

After finding your dream home you will need to apply for a guarantor with TRUST NET 21 with the form we will provide you. Along with the other necessary forms, listed below, please bring the completed form to our offices. After receiving your application form we will commence a simple screening process along with a simple check of your own, anyone who will be living with you and your emergency contact's phone numbers, so please also provide a time when it is best to call these numbers.



Necessary Documents

- Guarantor Application Form
- Photocopy of Passport (Page with your photo and page with most recent Japan entry stamp)
- Photocopy of Residence Card
- **Holders of student visas will need to provide a copy of their Student ID.**Sponsored visa holders will need to provide a copy of Proof of Sponsorship
- Sponsored visa holders will need to provide a copy of Proof of Sponsorship
 or Proof of Employment.
- ** All other visa holders will be interviewed personally and may be asked to provide other forms of proof of stay and / or employment.

Completion of Screening & Signing the Contract.

Upon GTN accepting your application you will be required to sign a Guarantor Commission Contract and a Tenant Contract. At this time you will also be required to pay Initial Guarantor Fees (Paid only ONCE at start of contract). There is also no need to worry as all necessary information concerning contracts and payments can be provided in English: your native language if required.







Application of Utilities and Moving In.

Internet, electricity, water and gas utilities must be applied for by the tenant, though TRUST NET 21 can provide FULL support for you in getting this done, and in English: your native language if necessary. Please let us know what you need help with. Please be aware that different services have different start times after application, for example, your internet service could possibly take at least one month to be tuned on. TRUST NET 21 can help you check all these things once you have applied.
